

**WMOA/WJAW "Official Standard Contest Rules". Revised 06/25/2025.**

**I. SPONSORS**

All contests presented in the programming of WMOA Local Radio, JAWS Classic Country, WJAW ESPN, or on social media pages and websites owned by JAWCO Inc. are sponsored by JAWCO Inc.

**II. ELIGIBILITY**

Age requirements vary by contest and prize, but all entrants must be legal residents of the 50 United States or the District of Columbia at the time of entry. Only one entry per person, family, or household per contest. An individual, household, or family may only win one prize every 30 days. Any employee of JAWCO Inc. and immediate family and household members of such individuals are NOT eligible to enter or play. "Family" shall mean parents, stepparents, children, stepchildren, siblings, stepsiblings, or spouses. "Household" shall mean people who share the same residence at least three months a year.

**III. HOW AND WHEN TO ENTER/NO PURCHASE NECESSARY.**

All "On Air" contests are entered by calling WMOA/WJAW (1-740-373-1490) when the personality tells you to dial to participate and win the specific prize being offered at that time. To win, you must be the designated caller. (i.e.: 3rd, 9th, or 100th). If the contest is a "trivia contest" or other game of skill, the first person with the correct answer is the winner. Contest held on WMOA/WJAW social media pages will contain their own instructions and must be followed as advised. Any age restrictions that apply to a specific contest or prize will be announced at the time that prize is offered. WMOA/WJAW is not responsible for a listener's inability to participate in our contests due to our broadcast schedule.

**IV. HOW AND WHEN WINNERS ARE SELECTED AND NOTIFIED.**

Participants in on-air contests are notified immediately that they have won when they call. Winners of contests on social media platforms will be notified by private message. Unless otherwise indicated, all prizes must be picked up at the WMOA/WJAW studios at 925 Lancaster St., Marietta, Oh. 45750 within 30 days of winning. Listeners are welcome to send the appropriate amount to cover postage if they choose to have their prize mailed. In certain instances, if a winner fails to pick up and or use their winnings, they may then be

deemed ineligible to win for up to 90 days.

## **V. PRIZE(S)**

The Approximate Retail Value of On-Air Prizes vary by contest. Federal, state, and local taxes, if any, are the sole responsibility of the winner, who will receive an IRS Form 1099 reflecting the final actual value of any prize valued at \$600 or more. Winners are not entitled to exchange or transfer prizes or to obtain cash or other substitutes, but Sponsor, in its sole discretion, may substitute prizes of equal or greater value.
